2. Professional Learning - Orange Shirt Day

Committee members asked to watch <u>Phyllis Webstad Orange Shirt Day video</u> ahead of meeting and wear an orange shirt. Brief presentation on the significance of Orange Shirt Day and the legacy of the Residential School system on past indigenous students, as well as the lasting impact for indigenous students today.

Action Items

Consider how the trauma and legacy of Residential Schools can today be understood as mental health "disabilities" that continue to support systemic and attitudinal barriers to accessibility for indigenous students and staff.

4. Multi-Year Accessibility Plan Collaborative Review and Working Session

MYAP Context

Context provided on renewed Multi-Year Accessibility Plan (MYAP) which "describes the measures that will be taken over the period of September 2020 to August 2025 to identify, remove, and prevent barriers to accessibility for everyone who learns, works and participates in the Board community." (MYAP, p. 5).

Various documents, resources and communications were consolidated and contributed to renewal of MYAP, which includes 4 new strategic accessibility goals developed in alignment with 4 priorities of the Board's Multi-Year Strategic Plan (MYSP) and Director's Action Plan (DAP) priorities:

- I. Provide Accessible Customer Service
- 2. Understand Accessibility as a Process
- 3. Engage the AODA Advisory Committee Collaborative
- 4. Publish an Annual Accessibility Report



Collaborative Review and Working Session via Breakout Rooms

5. Accessibility News Items

Mask exemption process and accessibility

- Discussed implications of students and/or staff who are medically exempted from wearing masks and possible competing rights situations.
- Differentiated between human rights as protected under the Human Rights Code and rights and freedoms under the Canadian Charter of Rights Freedoms.
- Requirement to wear a mask is applied to all groups equally and therefore does not discriminate based on any protected ground. Any duty to accommodate (i.e., mask exceptions) requests may be granted based on a relevant Code ground (e.g., disability).

New Accessibility Resource Hub

- HRCO in process of building a centralized web space for all new accessibility resources,
- Consolidating all existing AODA checklists/guidelines documents, and
