Describe your Drinking-Water System

Whitchurch Highlands PS is served by an onsite well water supply located on the southeast side of the school. The well is drilled to a depth of greater than 30 meters below grade. In order to comply with the minimum treatment requirements, an ultraviolet disinfection system was installed. As an extra precaution, chlorine feed equipment and turbidity meter were installed even though not required by the regulation. A professional engineer hired by the Board provided certification that the water works at the school meets minimum treatment requirements set forth by the regulation. A UPS power back up unit was installed for the turbidity meter, chlorine analyzer, chessell recorder and UV system to provide power for up to three hours in case of a power failure. Automatic shut off valves were installed which stops water flow in the event the UV disinfection system alarms due to loss of intensity. This prevents untreated water from being distributed to the drinking system when the UV cannot provide adequate disinfection. Filtration is provided by a 5 micron cartridge filter and an iron filter. A dual water softener system reduces the hardness concentration in the supplied water and to meet UV water quality requirements for disinfection. On March 9, 2023, the well pump ceased. Significant issues with the well were discovered and hauled water was brought in to supply the school with running water. The use of hauled water will continue until further notice. One treated sample was missed initially when there was no water hooked up to the school.
