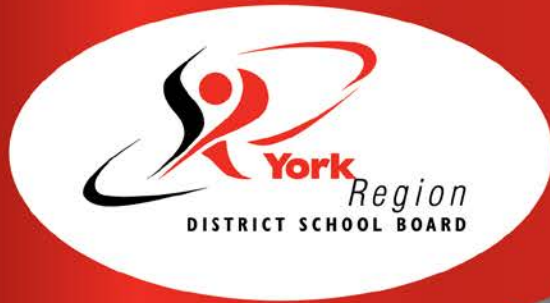

Land Acknowledgement

We affirm that we are all treaty people and acknowledge that the York Region District School Board is located on the lands of two treaties. These treaties are signed with the Mississaugas of the Credit First Nation and the First Nations of the Williams Treaties who are: the Mississaugas of Alderville, Curve Lake, Hiawatha, Scugog Island; and the Chippewas of Beausoleil, Rama, and Georgina Island our closest neighbour and partner in education.

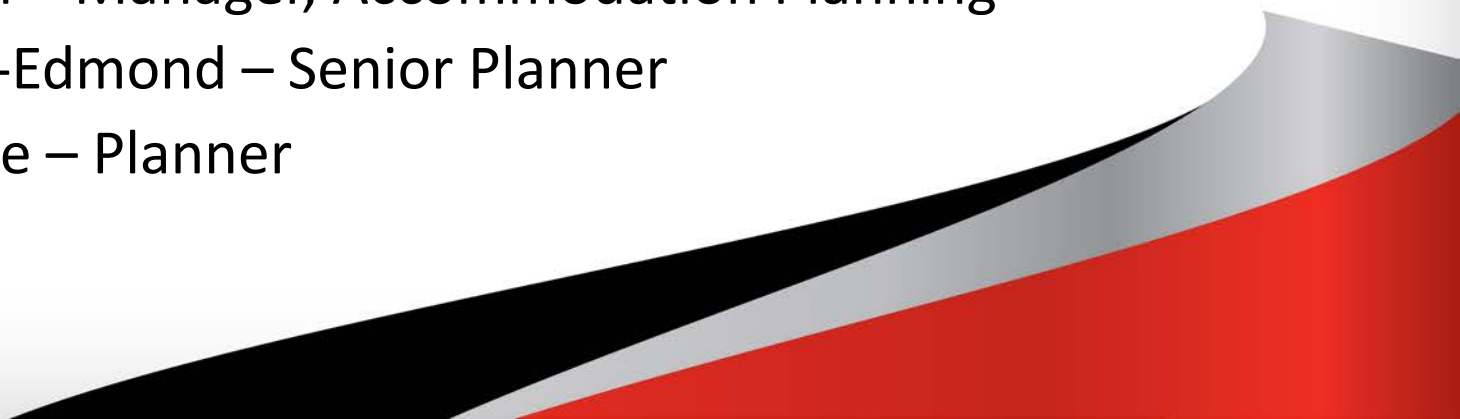

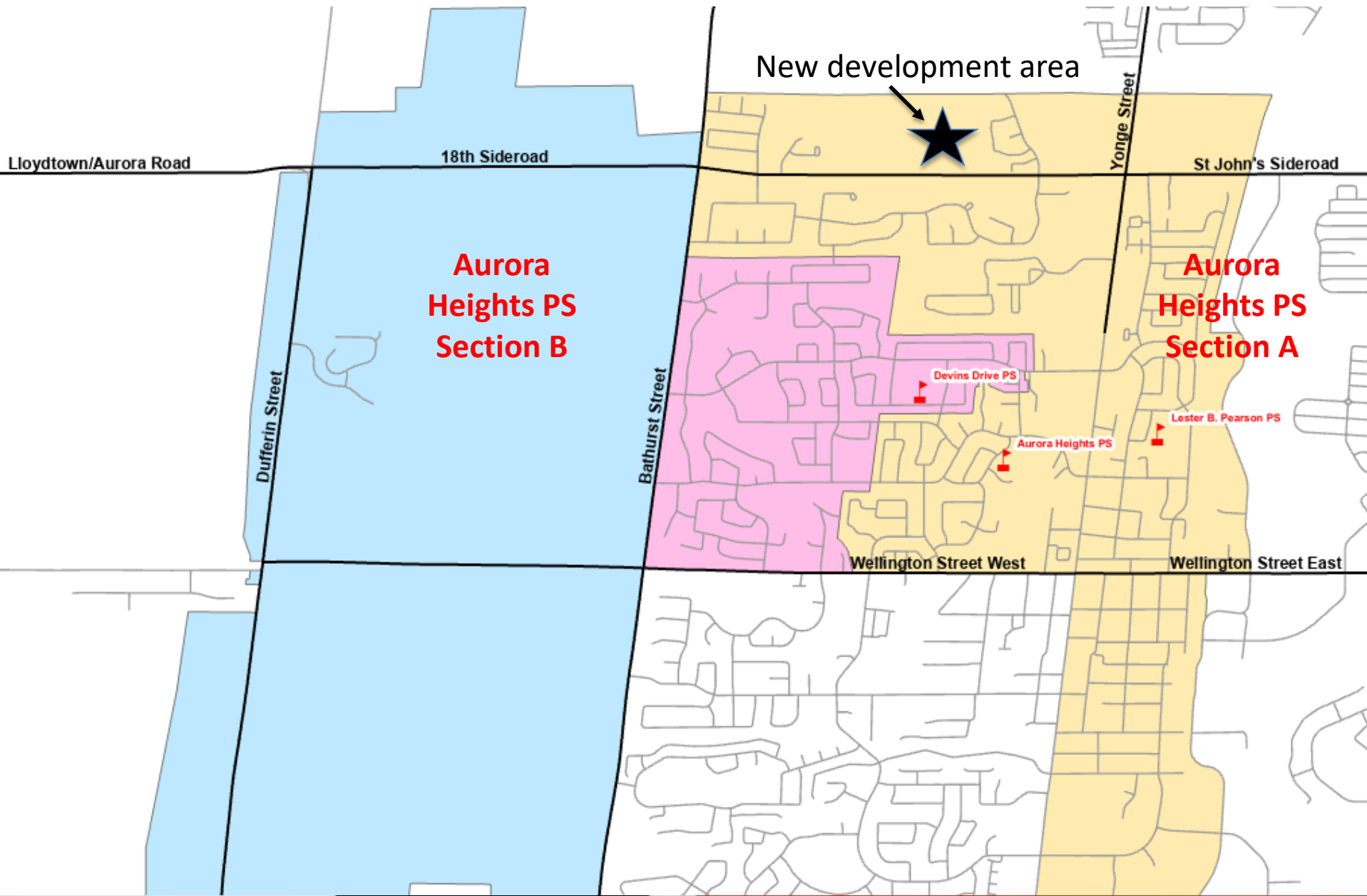

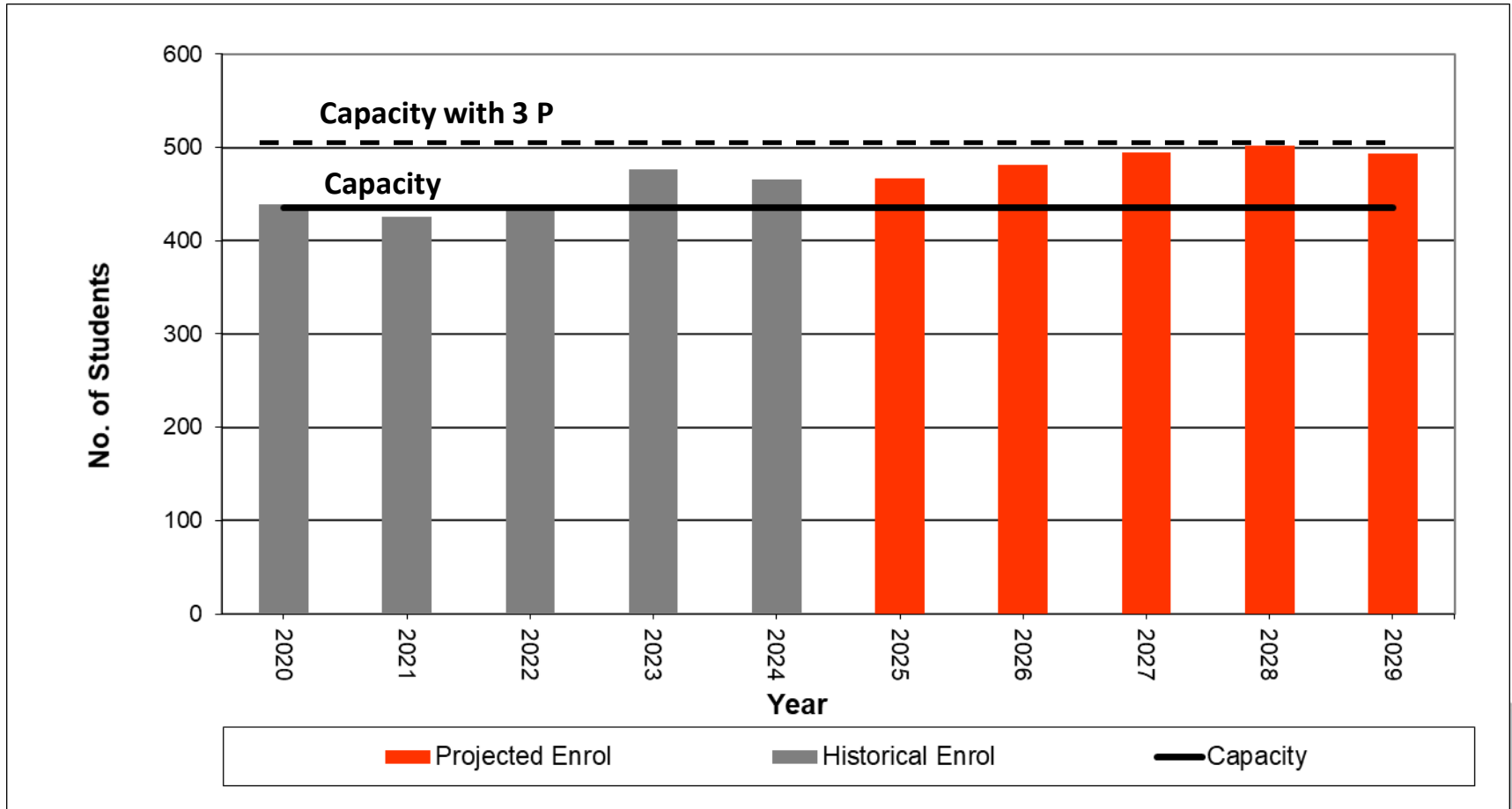
Background

- Enrolment growth at Aurora Heights PS
 - Limited portable space, 3 portables on site
 - Available school capacity at Devins Drive PS for additional students
 - French Immersion program moving back to Lester B. Pearson PS for September 2025

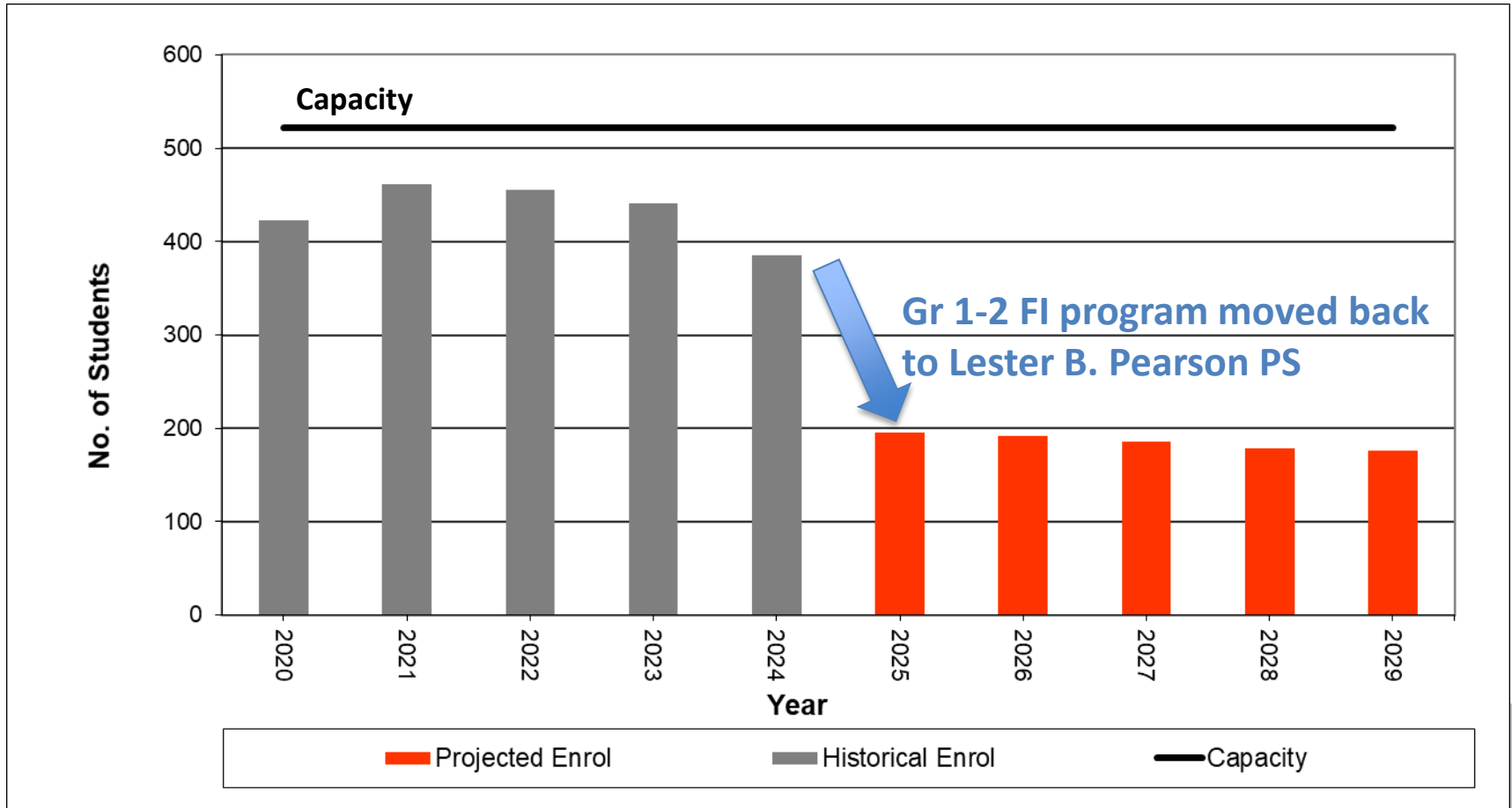
Current Boundaries



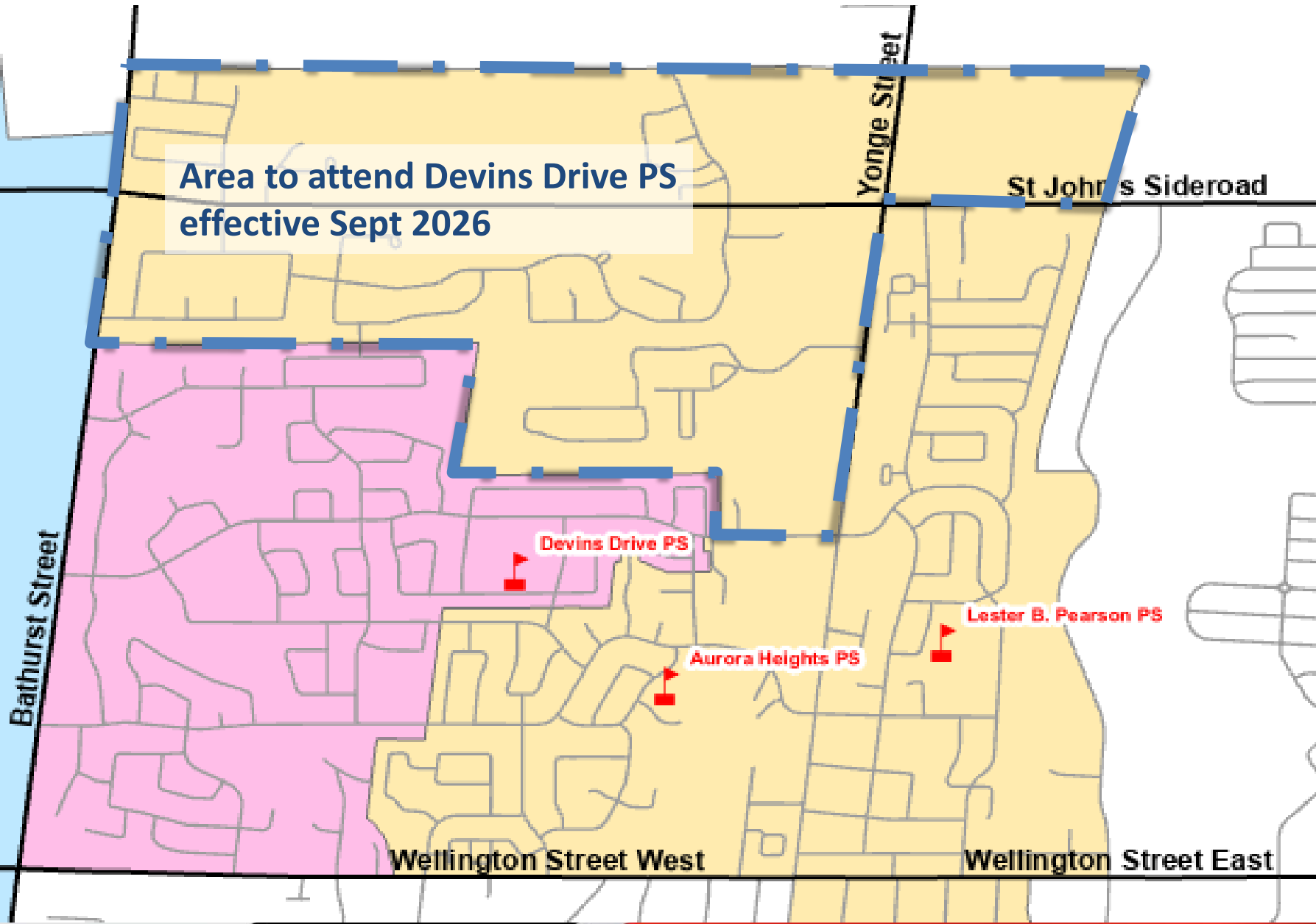
Current Aurora Heights PS Projection



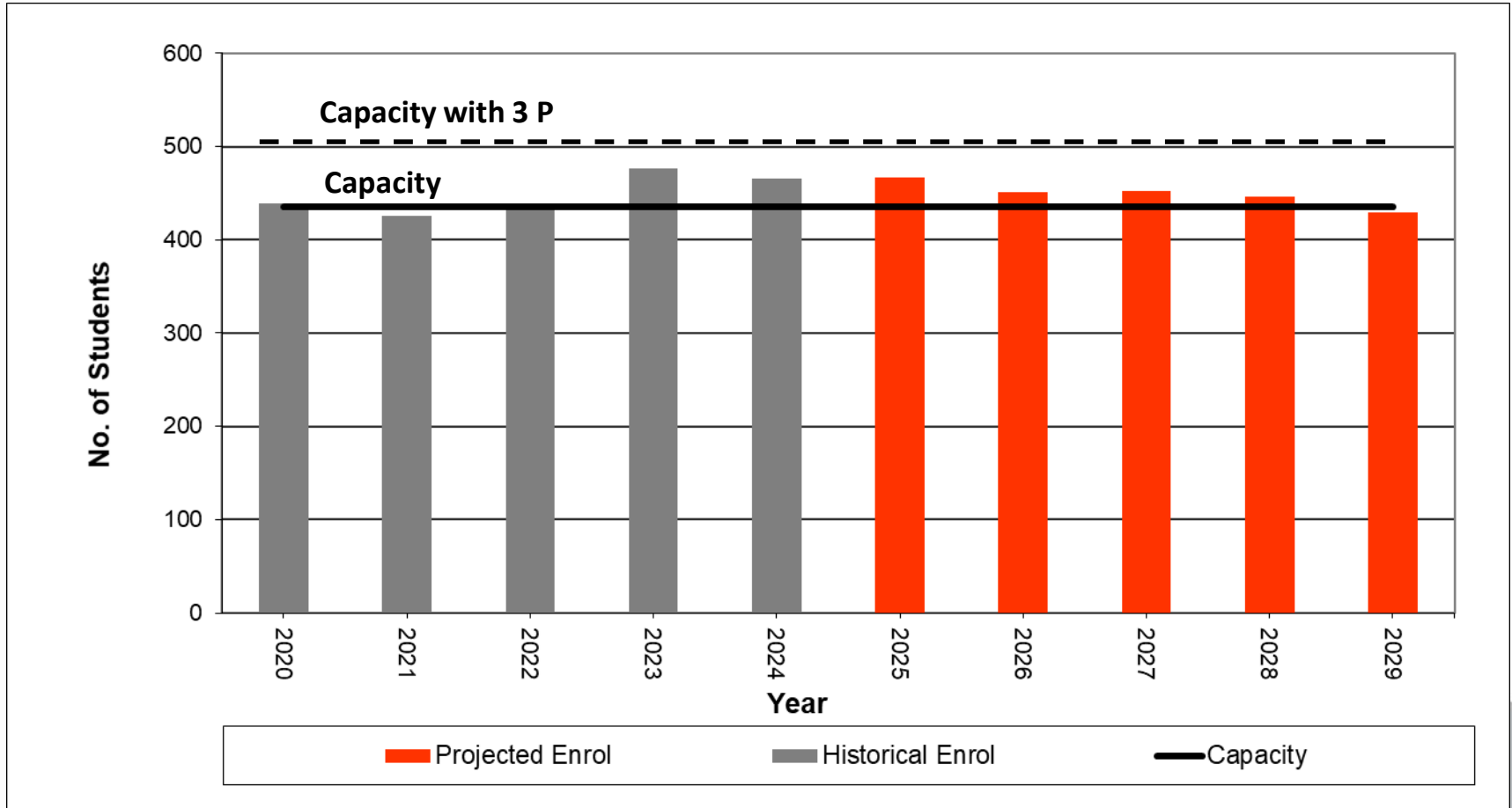
Current Devins Drive PS Projection



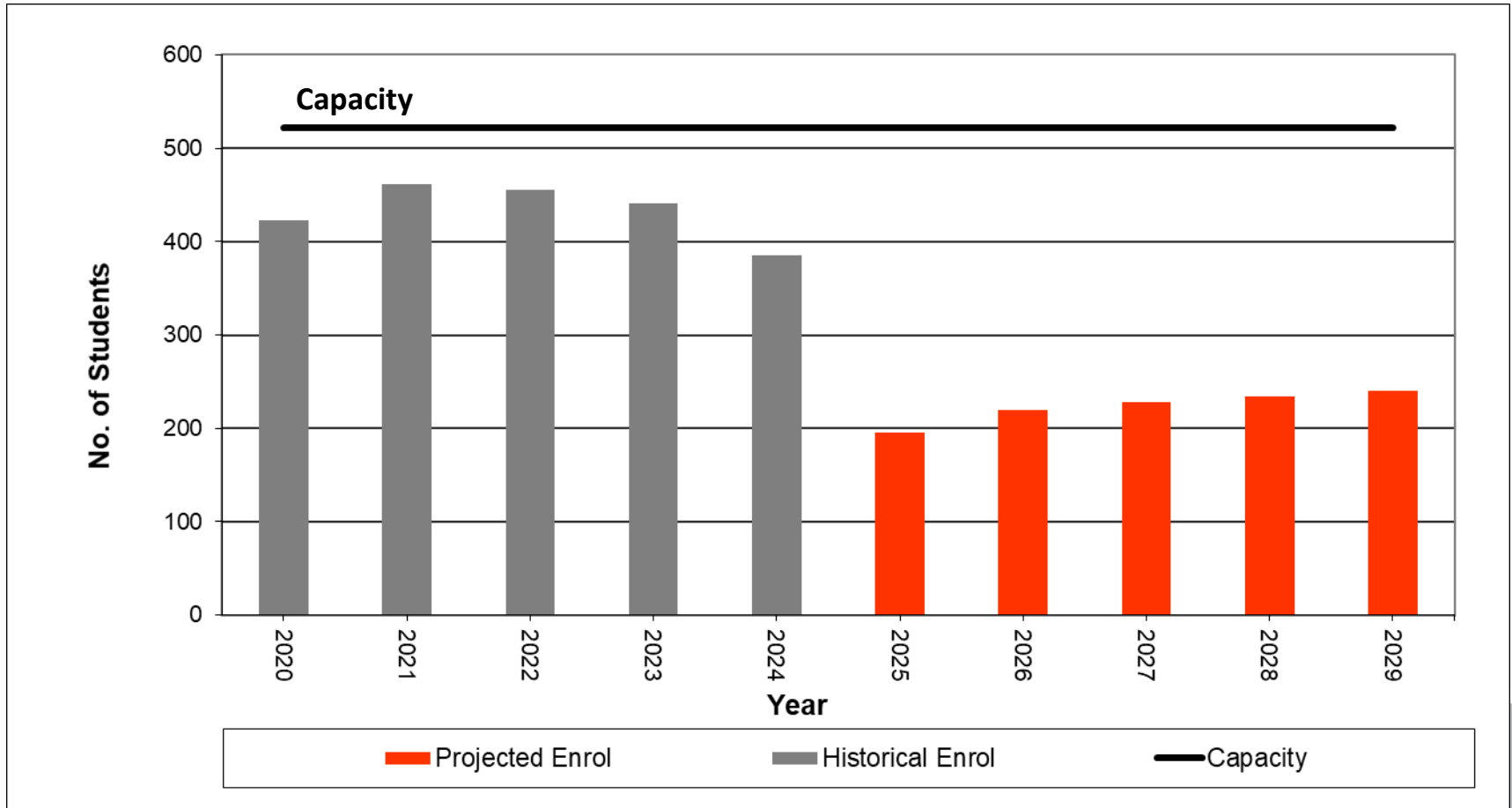
Proposed Boundary Change

Timing and Student Impact

- Boundary Change effective September 2026
 - Existing 2025-26 students are not impacted
 - Any new registrations for the 2026-27 school year, within the potential boundary change will be directed to attend Devins Drive PS starting September 2026
 - Existing students at Aurora Heights PS may remain at their current school until graduation with transportation provided (if eligible) or move to their new boundary school

Transportation (Policy 680.0)

- Students are eligible for transportation if:
 - JK-3 students live >1.2km from school
 - Grade 4-8 students >1.6km from school
 - Transportation stops will be posted in mid to late August 2026
 - Student Transportation Services will determine routes in summer months

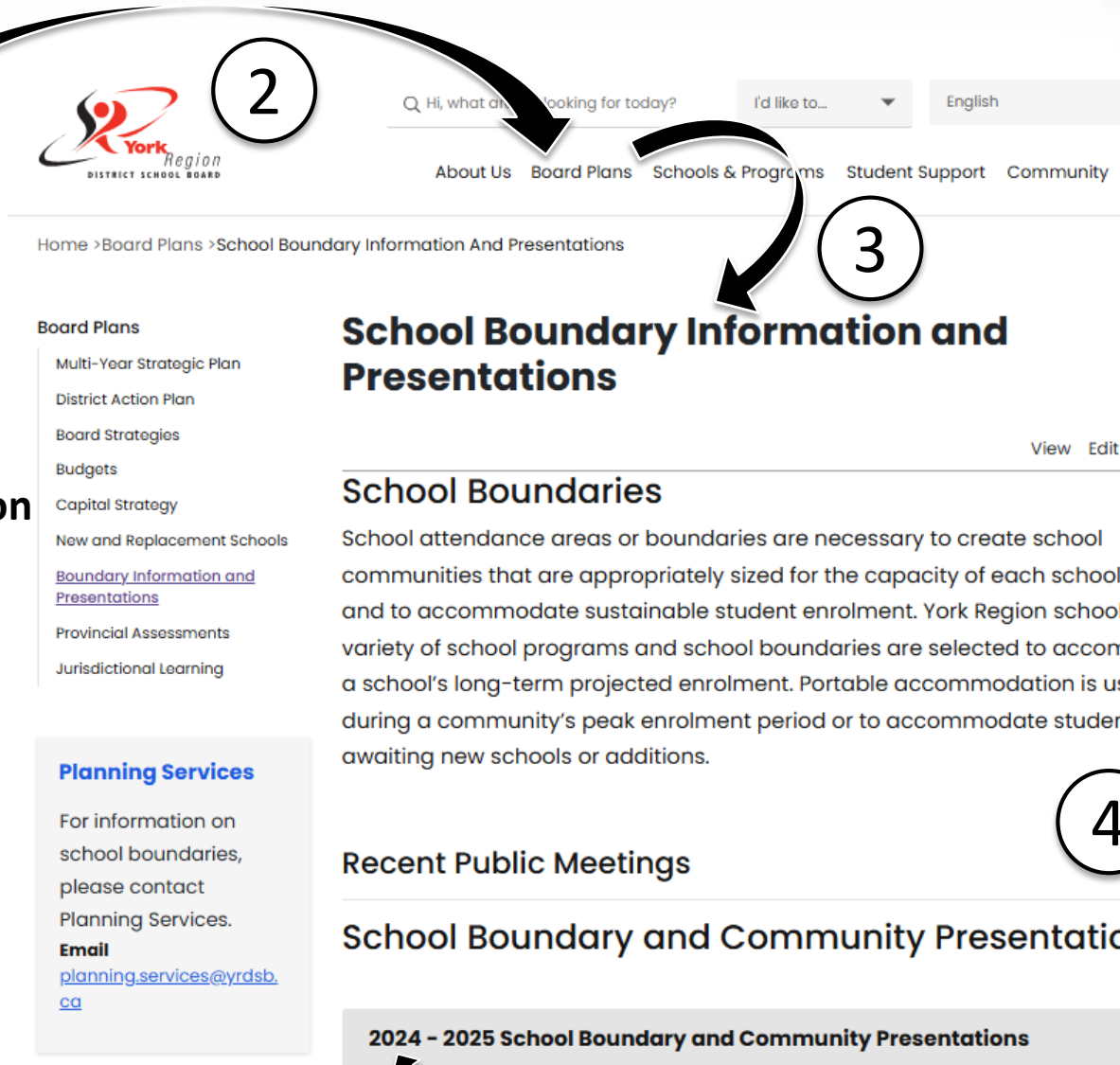
